**ORDER REVOKING DISPENSING
PRIVILEGES**

7 **INTRODUCTION**

8 On November 4, 2002 the Arizona Medical Board ("Board") was informed by the
9 Drug Enforcement Administration ("DEA") that the DEA had revoked the Certificate of
10 Registration of Jeri Hassman, M.D. ("Respondent"). Accordingly, the Board, through its
11 Executive Director, enters the following Order. A.R.S. § 32-1405(C)(28). Any violation of
12 this Order constitutes unprofessional conduct pursuant to A.R.S. § 32-1401(24)(r), and
13 may result in disciplinary action pursuant to A.R.S. § 32-1451.

15 **INTERIM ORDER**

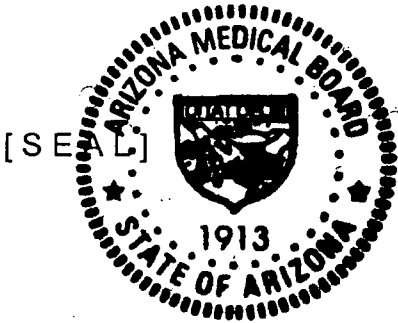
16 IT IS HEREBY ORDERED that:

- 17 1. Respondent's registration to dispense a controlled substance, prescription-
18 only drug, or prescription-only device is revoked based on Respondent's loss of her DEA
Certificate of Registration.
- 19 2. Because Respondent no longer possesses a DEA Certificate of Registration
20 she may no longer prescribe or dispense controlled substances. However, Respondent
21 may continue to see patients. In order to ensure continuity of care for her patients,
22 including their continuing to receive necessary medications, Respondent shall enter into
23 an agreement with another physician to prescribe or dispense any controlled substances
24 required by her patients or shall otherwise ensure continuity of care for her patients.

1 3. Respondent shall provide written notification to the Board of her plan for
2 complying with Paragraph 2 of this Order within 15 days from the date of this Order.

3 4. This is not a final decision by the Board regarding the pending investigative
4 file and as such is subject to modification and further consideration by the Board.
